² Under EO 1037 and its Implementing Rules & Regulation, and Memorandum Circulars, Subrogation to the rights of the Principal is allowed in the following cases: (1) Death of Principal; (2) Permanent disability; (3) Incapacity of the Principal due to (a) Civil Interdiction, (b) Being under Guardianship, or (c) Insanity; (4) Separation of spouses provided that the former Principal shall transfer in favor of the subrogated spouse his/her visa deposit ad shall be maintained by the latter as his/her 'sole account'.
