

## **Supplemental/Bid Bulletin**

### **Project: Purchase and Delivery of 15 units Desktop Computer**

#### **Pre-Bid Conference**

The procurement of 15 units Desktop Computer was posted in Philgeps, PRA website and conspicuous places last July 2, 2018 until July 23, 2018 at 12:00NN. The approved budget for the contract is Php 1,050,000.00.

The proponent submitted Certificate of Funds Availability (CAF) and included in PRA approved Corporate Budget, as explained by the BAC Chairperson Atty. Lisaca.

Ms. Ruby Abriol asked the prospective bidders if they have already downloaded the Bidding Documents in Philgeps. Upon confirmation from the prospective bidders, Ms. Abriol also asked them if they have ready questions or they want the proponent to explain the Terms of Reference one by one. The prospective bidders chose to let the proponent read and explain the Terms of Reference and they will raise their questions, if any.

Ms. Rogan, one of the member of the Technical Working Group (TWG), explained and discussed the Technical Specifications and Terms of Conditions, the prospective bidders raised the following questions/concerns:

Mr. Sta Ana from Moderntech Computer Systems, Inc asked about the window Server Standard 2012 R2 compatibility indicated in the specification.

Ms. Loriejane Hernandez, network specialist explained that Windows 10 is the OS for the desktop and they required window server standard 2012 R2 compatible or ready for this since our server is using the standard 2012 R2 already.

Mr. Rodolfo from Pronet Systems Integrated Network Solution Inc. asked if there is a specific technical specification for monitor.

Ms. Rogan just told them to follow the technical specifications for the monitor and also it is up to them if they will provide LED monitor or a higher specification.

Mr. Sta Ana inquired if the required bluetooth is just an attachment not built in?

Ms. Rogan said that attached Bluetooth device is acceptable.

Mr. Sta Ana also asked if they have to add another slot for the expansion of memory card.

The proponent said that it is much better if they will add slot for the expansion for the future used of the expansion of memory and if possible to have 3 slots ready.

Mr. Sta Ana clarified the 8x5 coverage of the technical supports?

The proponent said that it depends upon the issues or problems that might be encountered. Ms. Hernandez explained that if a problem occurs, 1st level is to call them and solve the problem over the phone. If phone diagnosis is not possible the 2nd level is for the technical support to come to the office to check and solve the problem. The 3rd level is to pull out the unit and replaced of the same specifications or higher if the problem cannot be resolved in the office.


After no more questions from the prospective bidders, Ms. Abriol reminded them of the schedule and explained that PRA will be having ISO schedule on the opening date. She asked the prospective bidders and the BAC members if possible to move the opening of Bids from July 23, 2018 to July 25, 2018 as requested by one of the members, Ms. Divine Hernandez. The BAC and the prospective bidders agreed to move the Opening of Bids on July 25, 2018 at 2:00PM.

Ms. Abriol also reminded the prospective bidders to submit one (1) Original Copy and two (2) Photocopy (Copy 1 and Copy 2) properly signed and sealed and should be submitted on or before July 25, 2018 12:00 PM at PRA Receiving Area.


There being no more agenda to discuss, the meeting adjourned at 11:31 in the morning.






